#### **Bid 21-124-3300 Dick Creek Sanitary Sewer & Pump Station**

**For:** Furnish all labor, equipment, and materials necessary to Lower Dick Creek Sanitary Sewer and Pump Station Phase-Out Project, located in southeast Forsyth County along Dick Creek between St. Marlo Pumping Station and Old Atlanta Road.

The project phases out and demolishes an existing pump station and installs new sewer which consists of 80 feet of 8-inch DIP, 280 feet of 12-inch DIP, 2,611 feet of 18-inch DIP, 14 Manholes, and 330 feet of steel casing pipe.
