ADDENDUM #2

Bid 22-120-3401 Litter Removal

For: Providing all labor, equipment and materials to pick-up and dispose of litter/trash on various roadways within Forsyth County, GA.

This addendum supersedes and supplements all portions of the bidding documents and becomes part of the contract documents for the above-referenced project.

Where any item called for in the specifications or indicated on the drawings is supplemented hereby, the original requirements shall remain in effect.

Where any original item is amended, voided or superseded hereby, the provision of such item not so specifically amended, voided or superseded shall remain in effect.

1. What was the approximate total annual contract value/spend in 2022, 2021 and 2020?
2020 - \$196,920, 2021 - \$265,248, 2022 - \$233,000
2. Are "Roadway miles" considered centerline miles or shoulder miles? **Centerline**
In the scope of work #2 it states: "Roadway and median pricing is based on roadway miles cleaned and on/off ramps are charged per ramp." This could be confusing and it is clearer to say "Miles billed for cleaning right-of-way and median is based on actual miles cleaned and on/off ramps are charged per ramp. GA 400 medians are doubled." The only reason for this sentence is to simply say that ramps are charged differently.
3. Are "Billable Miles" the same as "Roadway Miles"? **No** There are 68.08 centerline miles listed in the ITB, 86.92 miles if you double SR GA 400. Where do the other approximate 100 miles come from on an average full route? **The roads are listed below**
Are these mainly 2 lane county roads or is the billable mile considered a shoulder or median mile? **Billable miles are the actual miles cleaned which for a 2 lane road with no median would be centerline miles doubled. A road with a median is billed at center line miles doubled plus the actual mileage of the medians cleaned. The 3rd situation is GA 400 which is center line miles doubled plus actual median miles doubled. The median on GA 400 is narrow and really not any wider than a median on any other road however, we double it because it is such a busy highway.**
Standard state roadways cleaned under this contract:
SR 9, Milepoint 13.00 to 21.38
SR 9, Milepoint 9.67 to 0.00

SR GA 400, Milepoint 10.46 to 20.13

SR GA 400, Milepoint 9.17 to 0.00

SR 369, Milepoint 0.00 to 19.78

SR 306, Milepoint 12.75 to 3.88

SR 53 Milepoint 0.00 to 3.15

The county pays for actual miles cleaned on right of way and median with the exception of GA 400 which is doubled median miles. Ramps are billed per ramp. In the past some vendors have chosen to charge more per mile for work done on roads with more lanes which is the only reason that option was given in pricing.

Example: If vendor cleans both sides (right-of-ways) of 10 miles on GA 400 and the median they would be paid for 40 miles at the rate the vendor designates for 6 lane roadways. If vendor cleans both sides (right-of-way) of 20 miles on a 2 or 4 lane road with 5 miles of median they would be paid for 45 miles at the rate they designate for a 2 or 4 lane roadway.

4. Does the county have a map of on/off ramps or total quantity? **There is a total of 8 exits.**
5. Does the county have a designated site for disposal? **No, but litter must be disposed of at an appropriate and lawful site for trash disposal and the contractor must have the proper local and state permits to collect, haul and dispose of solid waste within 30 days of being awarded the bid.**
6. Is the contractor responsible for disposal/dumping charges? **Yes**
